#### Campaign Speech

I am here today with great joy and happiness to see the hearts, minds, and souls of each individual who came out to hear some great news today concerning issues that may trouble you.

I stand before you in this great city in Texas, as I represent Brazoria County, Galveston County, and Jefferson County, to announce to you my candidacy for the U. S. House of Representatives, District 14.

We are aware that there will be difficulties that lie in our paths, but this platform holds to the belief that all human beings are entitle to the Public Option Right to Economic Security.

Our past Supreme Court Justice Sandra Day O'Connor once said, "Our political and economic system is not something we inherit through our DNA but is something that must we be taught." She said if America wants to maintain its leadership role in the Free World it is imperative that we teach our political and economic systems to our future generations. Our political and economic systems are designed to be operational systems but we have allowed them to become executable systems.

We, as a society, spend all our lives trying to accumulate all the Federal Reserve notes we can, only to retire and discover we don't have enough to retire, because taxes, insurance, cost of living, and federal debt have moved the goal post. It is at that point we realize we were only Victims Of The Economy (VOTE).

Debt is credit and credit is debt. They are a mirror image of each other. We have allowed our credit to become debt and once that happens, our children and their children are servants to debt.

We must begin to adhere to political platforms from candidates who have developed and designed innovated ideas, that support the people's needs and not a party agenda, and that need must be created out of credit, not debt.

Listen to what the poet (Carl Sandburg) wrote many years ago. "Time is the coin of your life. It is the only coin you have, and only you can determine how it will be spent. Be careful lest you let other people spend it for you."

Human energy is the most value resource on the face of the earth and when you give your energy to someone that is your credit and time.

I am asking the citizens of District 14 to use their valuable time to unite and support a platform with innovative ideas that meet our goals and deliver economic prosperity to the entire district and nation.

#### Policy 1: Grey Water Renewable Energy

If we listen to what the political voices are saying, wind and solar energy are the future, but if you live in District 14, ask yourself the hard question: "Where are the wind and solar jobs in our area?" True they exist, but not in abundance in our local economies. Listen closely to what I am about say. We live on the Gulf Coast and the wind we need to generate the power of the windmill to make electricity is not here on a continual basis. That type of wind current occurs out west, through the Panhandle and east; it is not abundant for us on the Gulf Coast. That does not mean we are absent and do not have any valuable resources to support a green renewable energy industry.

As an aerospace test engineer at the Johnson Space Center, my job was to test the best of the best software systems for astronaut training and mission control training. By trade, I am a software test engineer with creative ideas.

It is a fact that every city in Brazoria County, Galveston County, and Jefferson County presently produces the raw resources within their own jurisdiction to transition all each city's waste water plants from diesel, gasoline, and electrical grids to renewable grey water energy. This would save the District 14 taxpayers millions in tax dollars and at the same time use renewable grey water green energy to power their waste water plants, street lights, and city government buildings and promote STEM technology and jobs within its own towns. We have the technology locally to be the first to produce a Grey Water Industry and produce the components that drive the industry. We also have the ability to

export out across the nation and the world the manufactured resources and funding they need to make the transition and sustain it. Other areas of importance this grey water industry would be successful with include farming and the oil industry. Imagine farmers using the grey water equipment to power their farm machinery. Imagine the oil companies having mobile grey water equipment to power their oil wells in remote areas. Imagine your homes, restaurants, schools, educational institutions all contributing to nationwide green grey water renewable energy and conserving our water resources.

Imagine a natural disaster such as hurricanes, storms, snow blizzards, power grids, and power blackouts but the lights still have power. That's the green grey water renewable energy industry that I plan to present to our Congress. This green grey water industry is an affordable industry that does not require raising the federal debt to create, no bonds or treasury notes to be bought or sold, it will not require raising taxes on opposing entities. This new grey water renewable industry will create many STEM and non-STEM jobs for local towns.

Policy 2: Support Our Justice System & Substance Recovery Treatment Programs

Remember what we said earlier, "Time is the coin of your life. It is the only coin you have, and only you can determine how it will be spent. Be careful lest you let other people spend it for you."

There are certain events in our society, such as probation within our justice system that we think our law enforcement officers, judges, probation officers, doctors, and treatment centers are trained to handle and fix, which they are indeed. The end result society looks for is the probationers and the recovering addict being integrated back into society and becoming an asset to society and a taxpaying law-abiding citizen. That's the intended goal. But such is not always the end result. There are many challenges in our probation system that slow the process down, such as increased caseloads, lack of legislative funding, lack of community programs, lack of community involvement, relapse in the individual,

lack of medical treatment programs, and lack of funding for medical programs and treatment housing centers.

Human energy is our most value asset, but when that energy is transitioned to be a probationer, case number, or a resident at a Recovery Center, it become a liability to the taxpayers, with no asset to the economy, and we become content with the situation. As your congressman, I will propose a plan for our justice system and recovery centers to enable the subjects to become an asset to society. Our plan will give the businesses and the community an opportunity to intervene, support, and understand our justice system and treatment recovery centers. This proposal must and will deliver tangible results to the businesses, communities, citizens, and the probationers. It is imperative that we intervene and support rehabilitating the probationer and recovering addict to become an asset to society rather than return to society as a liability. In support of our justice system's treatment recovery center, we will unveil a master program called, "The Renewal of Human Energy Achievement. With this program we will support our justice system by first supporting our judges and recovery centers with an educational community service program that only the judges and recovery centers have authority to request the subjects to enter, based on their crime or recovery stay. This community-based educational requirement will be rewarding to the probationer through ways such as, paying for some of their treatment recovery fees, drug testing, removing some of their felonies, and giving the subjects a Public Option Right to Economic Security and other selective programs while under the judge's and recovery center's authority. The goal is clear: decrease debt, decrease the social welfare program, decrease the cost of medical insurance, increase sales tax revenue, enable the probationer to become a lawabiding citizen and asset to community, protect the neighborhoods, and rebuild the family with businesses' and citizens' support. We cannot sit idly by and allow our society, cities, and neighborhoods to be neglected; we must intervene and support the very system that is designed to protect us. When the individual serves their probation or recovery center treatment time, we must have them at the same time transition back to the community through our Regional Economic Security LocalNet Consumer/Business. This will enable them to be productive and

support their communities, while serving their probation and recovery center time. The long-term goal is for them to remain in the program after completing their time. If they repeat their criminal activities (probation), there past felonies will become visible, and the judge will bar them from the program for life.

#### Policy 3: Water and Sewer Federal Infrastructure Support.

Every city in Congressional District 14 has water and sewer infrastructure problems on their agenda. We, as cities, create loans with money we do not have; we buy bonds and treasury notes, increase city taxes and fees, and we pass the debt on to the taxpayers, our children, grandchildren, and the next generation. Remember, human energy is the key to all activity on the face of the earth.

I plan to introduce a bill in Congress for water and sewer infrastructure support that requires the use of human energy as its entity substitute for borrowing and creating prolonged federal and local debt. This will save the district taxpayers huge sums in their budgeting and increase productivity. These resources will be purchased through the Public Option Right to Economic Security. It's time we explore modern ways of how we associate credit with debt in dealing with taxpayer-funded projects. All activity on earth requires human energy which means that human energy is measured in \$\$ signs. If that is true, we must begin transition of the link between borrowing loans, bonds, and treasury notes to the association of the value of the resources needed for the project and link human energy to the value of the resources needed and zero out interest and convert it into segments like retirement, ownership and income. This will automatically decrease the national debt, local debt, and local taxes.

### Policy 4 Affordable College Tuition (STEM)

We hear slogans like, "Vote for me and I will fight for your education" and "I support free college tuition." These are great talking points but ask them the hard question, "Show me your budget on how you plan to pay for the college tuition."

If we want to create high paying jobs for our students coming out of high school, let us not just create talking points but be proactive by using the resources we have. Let us start with our own district. Create green grey water renewable energy industry and we will have created STEM jobs locally in every town in District 14. Our funding for the STEM education will be funded through the Public Option Right to Economic Security. We can start by supporting students out of our own District 14 schools and supplying them with STEM scholarships. This new approach to funding college tuition in District 14 would be similar to funding of tuition for our District 14 Future Farmers of America/4H and Industrial skill jobs; they receive much of their support and training during high school and through our community support program. I am proposing to our businesses, consumers, farmers, and ranchers that we support this Green Renewable Grey Water industry for the sole purpose of supplying those students with STEM scholarships. They are our future of mankind, furthering our need to better our global existing and to better our lives with clean air, climate change, decrease of fossil fuel and environmental safety. Funding provided through District 14 Public Option Right to Economic Security, a district endowment program provided for resident students in District 14.

#### Policy 5: Federal Disaster Relief

We have been exposed to natural disasters since time began, and we have no control over those situations. But we do have the knowledge to address and prepare for some of them. District 14 consists of three counties: Brazoria County, Galveston County, and Jefferson County, and they are all on the Gulf Coast. When we encounter heavy flooding, heavy rains, and the release of water from reservoirs, all that imposing water must enter into the Gulf, so that water must travel through the rivers and streams, which at the same time causes floods and destruction in its path. I want to create a regional disaster relief program that works closely with our Army Corps of Engineers and identify routes and areas that can be addressed through the Public Option Right to Economic Security. We have citizens who have lived in these areas all their lives and these areas previously did

not flood, but flood now. Some of these citizens do not have the means or resources to move or fix their problems. These are taxpaying citizens that the cities and counties rely on as a tax base. Our goal is simple, provide resources to re-route water and elevate homes off the ground. This will save homeowners millions in insurance premiums.

Policy 6: Affordable Industrial Skills Education/ NCLB/ESSA Tutorial

NCLB mean No Child Left Behind. Under President Obama, it was changed to ESSA – Every Student Succeeds Act. It is a fact that not every student that graduates from high school will go to college or is college material. But every student that graduates from high school is entitled to have a career path that provides them with skills to create their own jobs and make a living much similar to skills of FFA and 4H. In the past, just about all the skilled jobs were once taught in high school, but somebody thought that everybody graduating from high school was college bound and college material and all these skilled job training courses were transitioned out of high school. But we see the negative results of that, lack of local skilled craftsmen, no carpenters, roofers, welders, medical skills, plumbers, small engine work, etc. This is the reality and result of those that were not college bound or college material. I am not going to use NCLB/ESSA as just a talking point; I am going to propose to us in District 14 a design and develop path to return these career skills back to the high school level.

The poor and the middle class needed skill-talent lie dormant in their communities because we have allowed it to be converted into a judicial cause number which is a liability to the community. The community is presently held at bay because there are no feasible funds to implement these industrial skills back into the schools. The cost of implementing these careers back in high school require taxpayer funding such as voting for school bonds or increasing school taxes. We, as citizens, hold the key to local carpenters, roofers, EMTs, welders, metal workers, home economics jobs, medical field careers, small engine mechanics, plumbers, etc. by making and creating productive students in the community.

First, I propose we have tutors in schools to assure the NCLB/ESSA standards are met. I strongly suggest the tutors be teachers in the schools and the teachers receive bonus pay for tutoring support through the Public Option Right to Economic Security. But with bonus pay must come positive results.

Second, the policy must involve working with local schools and technical institutions to transition those that are qualified and not pursuing a career through college to be certified for these skilled future jobs through these entities. The results of these jobs are that we will be creating an ownership society and businesses that do not require students to finish college and be laden down with hundreds of thousands of dollars in college debt. And when there is disaster, we do not have to bring in skilled workers from all over the country. This proposal will create new business owners that will have been created by its own citizens, existing businesses, and Historical Associations that provide support for the needs of the local communities. This will be part of the Public Option Right to Economic Security, in which all communities will prosper.

Conclusion: A support of this program is a fix to part of our probation program. You have the power to create many opportunities in your communities and society that do not require taxation but we have been institutionalized to execute everything by taxing the system and passing the debt on to our children and grandchildren. We all are going to have one challenge that we face with supporting this program, that challenge is finding an excuse of why we should not support this program.

# Policy 7: School National Security Agency (SNSA)

We live in a society that is protected by certain government agencies, such as FBI, CIA, NSA, Sheriff's department, and city police department. These agencies, we are fully aware and rely on, protect society with the latest and greatest technology. But we have independent school districts that rely on a physical human or no security at all to protect its students. I will introduce to Congress a bill that will establish a School National Security Agency (SNSA) with cyber

security ability that will give schools the ability to see within the social media realm. This type of security will identify criminal activities in the developmental stage. Most all our school shooting victims left their DNA on social media prior to their activities but it requires technical experts to examine and discern this type of data activity in order to prevent such tragic events. This SNSA office's task is to daily search the internet, chat rooms, observe campus activities, and to know its campus students' traits, attitudes, company, groups, and gangs. They must be masters of system administrator duties and social media activities and work hand-in-hand with local law enforcement agencies. The School National Security Agency will be funded through the Public Option Right to Economic Security. There will be no increase to the federal debt and no tax increase.

#### Policy 8: Federal Farmers and Ranchers Support

These are those that produce all the food that we eat. Many of them are working hard to feed the country and at the same time fighting to just hold on to their farms and ranches from foreclosures, bad years' profit, imports, debt, and competition. I want to propose implementing a program in District 14 that will take debt, which is a liability to our farmers and ranchers, and transition it into an asset for our regional District 14 farmers and ranchers with the support of eleven (11) selective associations through the Public Option Right to Economic Security.

We already have the raw resources to deliver to our farmers and ranchers; it is implementing Green Grey Water Renewable Energy. With this new technology farmers and ranchers can turn debt into a profit and compete in a global market. I want to introduce the potential Grey Water Renewable Energy plan which has the capability to power farm equipment and decrease the dependence on the use of fossil fuel. Also, we have our greatest asset to use which is human energy, in a rare form through the Public Option Right to Economic Security, to decrease the framers and rancher's debt. Farm machinery, seeds, and fertilizer to a farmer is considered a debt that needs to be transitioned to credit.

Policy 9: Future Farmers of America/4H Tuition Support

I fully agree that Future Farmers of America /4H is a great program support of students' needs in preparing for their career goals. It teaches the students about responsibility, ownership, work ethic, economics, and the food chain, and it holds many other valuable tools. The end results are for a student to purchase his animal or exhibit, train the animal or prepare the exhibit, and enter it in to contest. If the results are that the project did not place, we go back to the drawing table and start all over again. Then we tell the public that college tuition should be free, but I think the FFA/4H student have already paid for part of their tuition. Let's look at this from an economic viewpoint. The student purchases an animal, meaning the student exchanges credit for debt, and the economy profits; the student prepares a facility for the project, exchanging credit for debt, and the economy profits; the student purchases high-quality feed for a year, exchanging credit for debt, and the economy profit through sale tax; the FFA/4H student needs transportation and gas to support his project and the economy profits; the student purchases gear and tackle, and the economy profits. The student spends funds on water and electric bills, and the economy profits. The student has spent many thousands of dollars upfront and now the student enters the project for competition and the project does not place. I am not rejecting the system. I think it is time to make it better and more appealing, affordable, and rewarding and at the same time support our farmers and ranchers. There are other associations that support affordable college tuition that already back this idea and are willing to make it operational. I am proposing on the basis of making college tuition affordable that we support the Public Option Right to Economic Security. The students have demonstrated their ability to support the economy, but the economy has demonstrated its lack of support for affordable tuition. Here is the plan I will offer through the Public Right Option to Economic Security. A House Bill that will offer a number of funded vouchers to the farmers and ranchers to purchase the animals/projects that did no place or failed at the auction. If accepted, the animal/project will never enter into competition again but is released to the farmer/rancher for reproduction. This project is design to support the Every Student Succeeds Act and affordable student college tuition and give

support to our farmers and ranchers. The end result is the economy now supports and funds the college tuition for the students. We all profit from this formula and other district can support this program.

#### Policy 10: America International Immigration Job

Let's think outside of the box for a moment. The American economy is the most powerful economy in the history of the world. But think for a moment, without productive human energy the American economy would not be the world's number one economy. Our economy/government is indeed like Supreme Court Justice Sandra Day O'Conner once said, "It is not something we inherit from our DNA it is something that must be taught not just publicized." If people risk their lives, their children's lives, and give up their homeland to walk to America to seek a better life for themselves and their family, then we may need to look at the bigger picture. If I as an individual creates jobs and opportunities for the individual migrating to America, does it better the individual or does it better my country? Whichever answer you pick is correct. That is a form of what Supreme Court Justice Sandra Day O'Conner said, inheriting, but never coming to the knowledge of teaching your system to better others.

Let's be wise economically and care for the immigrant. Jobs must be in water construction, sewer construction, housing construction, medical, teaching school, administration, engineering, farming and ranching. We should always welcome immigrants to the United States, but let's help make their economic conditions better so they will have a choice. Human energy is the key to all activity on the face of the earth, with many Americans working with no company retirement program, this will be a marvelous opportunity for America to pass on and to teach its economic skills abroad and capitalize on the return benefits its citizens, industries, and economy would receive.

#### Policy 11: Affordable Medicare for all

We live in the wealthiest country in the world, and notice I did not say the richest, there is a difference. Once we begin to understand the difference between being wealthy and rich, we might be able to provide Affordable Medicare and Healthcare that everyone will support. Why is it that all the resources that the earth holds contains a value attach to it, i.e. oil, wheat, corn, gold, silver, cattle and etc., and a tax added to it and it is inserted inside the economy? But when it comes to human energy, it is not a part of the economy, there is no funds allocated to fund human energy. Human energy is the most valuable resource on the face of the earth; it drives the economy and it is the economy. You are the principle and the interest and the taxes you pay are the return of the principle to the originator. If you want to fund Medicare, insert it inside the economy the same way all goods and services are inserted as part of the economy. Give the people a Public Option Right to Economic Security and that will automatically put Medicare and Healthcare in the economy and everybody will benefit. Under the Public Option Right to Economic Security, every business, no matter how many employees are covered, and every human that supports Public Option Right to Economic Security, will have Affordable Medicare. Option 1 Funded Medicare supports \$118,872,000,000/ year, Option 2 Funded Medicare \$257,744,000,000/ year, Option 3 Funded Medicare \$356,616,000.000/ year, Option 4 Funded Medicare \$475,488,000,000/ year. No increase in the national debt, no raising of taxes on anyone, no taking funds from one program to pay for another; just put a value on Medicare and tie it to human energy and put it inside the economy, its pure math.

### Policy 12: Federal Economic Security LocalNet Consumer/Business

If we want to live the American Dream, we must be willing to accept policy change that will benefit our resource market, business market, and the household market. The resource market and the business market must begin to entertain the idea of the household market as being an ownership society and not a market of consumption and expenditures. The households are the ultimate owners to all

the resources of the country. Our resources are a created market which carries intrinsic value along with supplying jobs, retirements, and insurance, but we have transformed it into a tool used to create poverty and debt through taxation. The resource market is the manufacturer of all our resources and must remain strong in the economy. Our business market purchases the resource market resources and creates what we call a product market and calls the resources goods and services. Another market that is called households, buys the goods and services from the business market. When the goods and services are bought, they are treated as consumption and expenditures and you are handed by the business a receipt, and the process starts all over again. That's the Circular Flow of Income and Output that is not the American Dream, it is simply the execution of the Economy, that's Corporate America's dream.

The household will never outperform the economy because you are the principle and the interest and the tax on the products and services is a return of the principle. Nothing's wrong with that formula. We have been accustomed to executing the economy; we need to begin operating the economy and our local businesses and communities will grow and the sales tax base will increase, and your local property taxes will decrease. Under my leadership I will offer my plan to Congress that will transform the household market into an Ownership Society. This Ownership Society will support the resources market, and the business market relies less on the federal government. I have a policy designed to reward businesses and households that treat their local economy as ownership society and let the economy begin to work for them and reward them. The situation that exists now is that you are working for the economy and the local business is working for the resource market and the federal government. You are operating an ownership society every day when you walk into business and spend your money, you just not receiving any benefits

This leaves you, your local businesses, and schools with high property tax, high school tax, high sale tax, high debt, and it will get even worse with online sales on the increase. I have designed the Public Option Right to Economic Security for the businesses in District 14 that will enable them to increase their productivity, citizens (become Ownership Society) save more of their income and its cities

revenue, increase in the state sale tax. But with the household being the link to the success of the economy, they must obtain a degree of ownership in the transition of goods and services because they are ultimately the owner of the resources. I believe in the increase of the minimum wage but I also believe that citizens should have Access to more Income which have created. Give me an increase to minimum wage and the results will be all things will remain the same. Give me Access to more Income and I will change that person life. But you must first give the person a Public Option Right to Economic Security, let the individual make the choice. I support both option.

We should promote the economy as a retirement tool and let it provide for us as we have provided for it, rather than retiring and allowing the economy to live off your retirement. To achieve the American Dream, the household market must operate the economy in the same fashion as they do the stock market. And to do it, they should be entitled to Public Option Right to Economic Security.

#### Policy 13: Federal Recovery Treatment Programs

Prescription drugs are another clear example of how the resources market executes its plan. The maker of the drugs has the rights to the drug, and the Corporate American dream is to make as much profit as it can. The manufacturer (resources market) produces the drugs and transitions it to the business market called pharmacies. At that point the drugs become a product called prescriptions and the household performs their task by buying the product (consumption expenditures) and the cycle begins. I propose a policy call Public Option Right to Economic Security which offers to negotiate a plan for the drugs at pharmacies for the entire district's recovery treatment programs. But instead of having lobbies for the drug manufacturers, give them and the citizens of District 14 the option to support the Public Option Right to Economic Security. This automatically creates stiff competition and the price of drugs will quickly decrease.

## Policy 14: Budget Cost

Top Secret, I have a budget that does not require increasing taxes. There will be no borrowing of foreign debt, no special tax on the rich, no bond sale, no buying and selling of treasury notes, no driving up the national debt. It will create jobs, increase retirements, decrease taxes, increase productivity. The budget will be revealed later.
